**If the youth violates the ASD/EHM contract, ASD may direct the youth to report to secure detention immediately without further court order. If the youth fails to appear as directed, ASD shall notify the court and ask the court to issue a warrant for the youth's arrest. If detained, a detention review hearing shall be held at 8:30 a.m. in Seattle the next court day.**

**SECURE DETENTION - no waiting list.** Serve \_\_\_\_\_ days. Report by \_\_\_\_\_  
 While in detention, the DAJD shall provide the youth with the necessary tools (paper, pencil, free phone) to purge the contempt, within DAJD standards.
