THIS MATTER having come on before the undersigned judge of this court, the court examined the attached report of Western State Hospital _____, and considered the records herein, and heard the statements of the defendant and counsel;

THE COURT NOW FINDS THAT:

1. Defendant is presently incompetent to stand trial;
2. Defendant presents a substantial danger to others or presents a substantial likelihood of committing felonious acts jeopardizing public safety or security;
3. There is a substantial probability that the defendant will regain competency within a reasonable period of time.

1 IT IS THEREFORE ORDERED PURSUANT TO RCW 10.77.090:

2 1. That the defendant is committed to Western State Hospital for a period of 180
3 days, or until such earlier time as the defendant becomes competent to stand trial.

4 2. Pursuant to CrR 3.3, the time for trial in the above-entitled matter is tolled until such
5 time as the defendant is found competent to stand trial.

6 3. If the defendant does not object, psychotropic medication may be administered to the
7 defendant as deemed clinically appropriate by the staff of Western State Hospital as the court
8 finds that there is no less intrusive form of treatment which is likely to restore the defendant's
9 competency.

10 [] Clinically appropriate psychotropic medications may also be administered against
11 the defendant's will if necessary.

12 4. The King County Department of Adult and Juvenile Detention shall transport the
13 defendant to Western State Hospital and shall return him/her to the King County Jail at such time
14 as he/she becomes competent or ninety days has elapsed.

15 5. When the defendant regains competency, or at the end of the ninety day period, a
16 medical report shall be provided to the chief criminal judge of the court in which the criminal
17 proceeding is pending, counsel for both parties, and the King County Jail Psychiatric Unit
18 professional staff, setting forth the findings of the staff, detailing his/her present mental
19 condition, and indicating whether he/she is competent to enter a plea to the charges and to stand
20 trial and whether psychotropic medications will be required to assist the defendant to maintain
21 competency.
