Waxaan halkan ku caddaynayaa in guriga ku yaala lambarka dhulka ee kor ku xusan uu yahay hanti amaanad (asset of trust). Waxaa taa dheeraad u ah, waxaan caddeynayaa in amaanadda (trust) ay buuxineyso shuruudaha mulkiilenimada sida lagu qeexay ee hoosta yimaada (**calaamadeey mid**):

- WAC 458-16A-100(25)(a) — Waxaad qabsatay guri markii Aad guriga ku wareejinaysay ururka/shirkadda ama guri noolaleed ayaa markii dambe lagu soo wareejiyey warqad guri (subarloogo). Ku soo lifaaq nuqlka warqada guriga (subarloogada).
- WAC 458-16A-100(25)(b) — Waxaad tahay Deganaha ama abuuraha amaanada (trust) (dib looga qaadi karo ama aan dib looga qaadi karin) waxaadna isa siisey danaha ka-faa'iideystaha ee guriga assaasiga ah, ama qeybtan gaarka ah ee amaanada (trust), iyo in danaha ka faa'iidaysiga ay soconayaan ugu yaraan inta aad nooshahay.
- WAC 458-16A-100(25)(c) — Amaanada (trust) waa mid aan dib loo celin karin adigana waxaad tahay ka-faa'iideystaha. Waxaa lagu siiyay danaha ka-faa'iidaysiga ee qaybta guriga assaasiga ah ee amaanada (trust) ugu yaraan inta aad nooshahay.

Tilmaamaha

Fadlan la xiriir Xafiiska Qiimeeyaha Degmadaada si aad u hesho wixii caawimaad ah oo la xiriira buuxinta foomkan.

Sharciga ma oggola in lahaanshaha guriga loo maro Urur iyadoo ujeedadu tahay in la buuxiyo shuruudaha mulkiilenimada ee Barnaamijka Cashuur-Ka-Dhaafida Guryaha Muwaadiniinta Waayeelka ah iyo DadkaNaafada ah. Si qiimeeyaha uu u go'aamiyo in aad buuxisay shuruudaha mulkiilenimada iyo in kale marka guriga uu yahay hantida amaanada (trust), waa inaad bixisaa nuqul ah amaanada (trust) (ama qeybaha amaanada) oo caddaynaya in shuruuda mulkiilenimada la buuxiyey.

Waxaad buuxin kartaa foomkan adiga naftaada ama waxaad caawimaad ka codsan kartaa qareenkaaga. Si aad ugu qalanto ka-dhaafitaanka, waa inaad lahayd guriga wakhtiga aad buuxinaysay kharashka, hanti nololeed ahaan, ama qandaraas iibsi ahaan. Sidoo kale, heshiiska kirada ee nolosha ayaa loo aqoonsan karaa guriga noolasha (RCW 84.36.381(2)).

Sidaa darteed, si loo buuxiyo shuruudaha mulkiilenimada ee loogu talagalay barnaamijkan ka cafinta canshuurta hantida/guriga marka hantida ay tahay hanti amaanad (trust), Amaanaddaas (trust) waa in ay muujisaa danta "guriga nolosha" ee guriga ay tahay in laga cafiyo qofka codsanaya ka cafinta canshuurta. Si loo buuxiyo shuruudahaas, mid ka mid ah waxyabahan soo socda waa in la helaa:

- Danta guriga noloshada waa in uu haystay qofka codsanaya ka cafinta canshuurta markii hantida loo wareejinayay amaanada (trust).
- Danta guriga noolasha waa in markii dambe lagu wareejiyey warqadda guriga (subarloogo) la siiyey qofka codsanaya ka cafinta canshuurta.
- Amaanada waa in ay ku jirtaa luqad muujineysa danta guriga noolasha ee deganaanshaha si looga dhaaf qofka codsanaya ka cafinta canshuurta.

WAC 458-16A-100 (23), (25), iyo (26) ayaa caddaynaya shuruudaha mulkiilenimada:

(23) Heshiiska nolosha oo dhan ah. Hashiiska nolosha oo dhan ah waxaa loola jeedaa in heshiiska kiro uu joogsanayo marka qofka guriga ijartay uu dhinto.

(25) Guriga noolasha. Guriga nolosha waxaa loola jeedaa guri muddadiisu ay ku egtahay nolosha qofka haysta mulkiilenimada ama qof kale.

- (a) Qabsashada guri nolosha si u ah degaanka assaasiga ah ee la galley amaanad (trust) ama lagu wareejiyey mid kale waa guri nolosha.
- (b) Danta ka faa'iidaysiga ee amaanada (trust) waxaa loo tixgeliya guriga nolosha ee daganaha ee amaanada (trust) ee dib looga qaadi karo ama aan dib looga qaadi karin kaas oo uu naftiisa/nafteeda u siinayo danta ka faa'iidaysiga si toos ah ee degaankiisa/gurigiisa assaasiga ah, ama qeybta amaanada (trust) ee ka kooban gurigiisa/degaankiisa shakhsii ahaaneed, ugu yaraan muddada noloshiisa ama nolosheeda oo dhan.
- (c) Danta ka faa'iidaysiga ee amaanada (trust) ee dib looga qaadi karin waxaa loo tixgeliya guriga nolosha, ama heshiiska kirada ee nolosha oo dhan ah ee ka faa'iidaystaha la siiyay danta ka faa'iidaysiga ee matalaysa gurigiisa/gurigeeda asaasiga ah ee loo haysto amaanad (trust) aan laga qaadi karin, haddii danta ka faa'iidaysiga lagu bixiyo sida hoos imaanaysa qodobka amaanada (trust) ilaa muddo aan ka yareyn nolosha ka faa'iidaystaha.

(26) Lahaansho. Lahaansho waxaa ka mid ah **qandaraaska iibsashada** iyo sidoo kale **kharashka, guriga noolasha** iyo heshiis kiro oo nolosha oo dhan ah. Guri ay leeyihii bulsho is qabta ama lammaane ahaan u wadaaga guri ama uu leeyahay la-dagane waxaa loo tixgelinaya in uu leeyahay lamaane walba ama qof kasta oo guri la wadaaga ama guri la-dagane walba.
