5	Resolution 08-01, establishing a 2008 scope of work for the Board consistent with the
6	structure and guiding principles of the Public Health Operational Master Plan
7	("PHOMP"); and
8	WHEREAS, Resolution 08-01 establishes committees in the areas of protection,
9	promotion, provision and financing and organizational attributes, and directs the
10	development of committee work programs for board review and approval; and
11	WHEREAS, in accordance with the PHOMP guiding principle "Driven by Social
12	Justice," each committee's work program shall include a plan for how it will address
13	health disparities, if and as appropriate; and
14	WHEREAS, in accordance with the PHOMP guiding principle "Based on Science
15	and Evidence," each committee's work program shall include expected outcomes and
16	measures of success for its work;

## King County Board of Health Injury Prevention Committee

## Proposed Name: Injury Prevention Committee with a focus on pedestrian safety

## **Proposed Scope of Work:**

The committee will identify key elements to include in pedestrian master plans. The committee will bring the key elements to the BOH for endorsement; the committee will also develop a BOH advocacy plan to work with communities in adopting pedestrian master plans that include those elements.

Addressing Health Disparities:

The committee will choose elements of a pedestrian master plan for the BOH to support that will also impact health disparities.

Deliverables:

- Key elements of a model pedestrian safety plan
- Advocacy plan
- Reports to the BOH on expected outcomes and measures of success

Expected Outcomes and Measures of Success:

- Timely implementation of the committee work plan
- Increased understanding of pedestrian fatalities and injuries in the County
- Identification of effective, evidence-based elements to include in a model plan
- Outreach to local cities and communities and adoption by them of key elements in their pedestrian safety plans or other policy documents

## **Proposed Timeline/Schedule:**

The Committee will present its final recommendations on key elements for Board action prior to September 2008, with advocacy to follow thereafter.

## King County Board of Health Obesity Prevention Committee

### Name: Obesity Prevention Committee with a focus on school nutrition

#### Scope of Work:

The Obesity Prevention committee will prioritize two or three school nutrition policies for the BOH to support and focus on (i.e. no soda in vending machines) and will work with schools to identify barriers to implementing those policies. The committee will then develop a plan for BOH advocacy and assistance for implementing the policies.

#### Addressing Health Disparities:

The committee will choose nutrition policies for the BOH to support that will also impact health disparities.

Deliverables:

- 2 or 3 school nutrition policies for the BOH to support
- Identified barriers to implementing those policies
- BOH advocacy and implementation assistance plan

Expected Outcomes and Measures of Success:

- Timely implementation of the committee work plan
- Identification of effective, evidence-based school nutrition policies that support obesity prevention and good nutrition
- Identification of key barriers to implementing such policies that can be addressed at the local level
- Identification of policy changes to reduce these barriers and a work plan that addresses them
- Advocacy at state and federal levels for policy changes and other measures that support the committee's work and good nutrition in schools
- Successful implementation of policies in schools

### Timeline/Schedule:

The committee will complete its work by the end of 2008.

## King County Board of Health Provision Committee

## Name: Provision Committee

### Scope of Work:

The BOH Provision Committee will provide leadership and policy-level guidance for the department as it begins to implement the PHOMP provision strategies in 2008, as defined in the BOH PHOMP 2008 Provision Work Plan. Through review of the major deliverables in the Provision Work Plan, the Committee will identify policy implications and linkages as the assessment, policy development, and assurance strategies are implemented. The Committee will provide input to the department on the work plan as it evolves and on the development of a BOH PHOMP 2009 provision work plan.

### Addressing Health Disparities:

All of the provision work deals with access to healthcare for low-income residents and is inherently focused on health disparities.

Deliverables:

- Quarterly briefings for BOH on significant milestones, findings, or potential policy recommendations
- Advocacy at state and federal levels
- BOH PHOMP 2009 provision work plan

Expected Outcomes and Measures of Success:

- Timely implementation of the provision work plan
- Development of a BOH PHOMP provision work plan for 2009
- Better understanding of populations without adequate access to care
- Identification of key strategies to increase collaboration and identify methods to improve planning, efficiency and integration within the safety net system of care.
- Advocacy at state and federal levels for healthcare reform

## Timeline/Schedule:
