ENERGY & UTILITIES ASSISTANCE

CITY OF SEATTLE UTILITY DISCOUNT PROGRAM

Helps income qualified Seattle City Light (SCL) customers lower their electric bills by 60%. SCL customers will also receive 50% off their water, sewer and garbage bills if enrolled in this program. Households in federally subsidized housing are not eligible. City of Seattle customers can call 206-684-0268 for assistance.

WORKING CONNECTIONS CHILD CARD PROGRAM (WCCC)

Helps families with low incomes pay for child care while they work or meet WorkFirst participation requirements.

CITY OF SEATTLE COMPREHENSIVE CHILD CARE PROGRAM

Helps income-eligible working families living within the Seattle City limits pay for child care services for children ages one month to 13 years.

CHAP is a telephone assistance program serving King County residents by enrolling them into health insurance (Washington Apple Health (Medicaid) or Qualified Health Plan), ORCA LIFT, Food Assistance, Energy Assistance or the Breast, Cervical & Colon Health Program. We also help residents access other health care services including finding a medical and dental home. Our services are free and confidential.

WHAT WE DO:

- Enrollment: We enroll King County residents into health insurance, ORCA LIFT, Basic Food and other public benefit programs.
- ◆ Education: We help residents of King County understand how to navigator the health care system in Washington State.
- Assure Access: We provide trainings and technical assistance to our community partners on health insurance, health care access, ORCA Lift and other public benefit programs.
- Collaboration: We achieve system-wide changes that improve access to health care by working with our community partners to help us identify system barriers and work together to eliminate these barriers.

ORCA LIFT REDUCED FARE PROGRAM

ORCA LIFT, offers reduced transit fare for qualifying adults (19-64) to help reduce your transportation cost. Once you qualify for the ORCA LIFT program, you will receive an ORCA LIFT card registered to your name, with the same features as every ORCA card. Eligibility is based on your income for the most recent 30 days. If you are enrolled in Washington Apple Health (Medicaid/ ProviderOne) or receiving Basic Food benefits you are already eligible for an ORCA LIFT card. Once eligible your fare in most cases is reduce to \$1.50 or you can get a monthly bus pass for as little as \$54.00.

Your ORCA LIFT card can be used on the following transportation systems: Metro buses, Sound Transit buses, Sound Transit Link Light Rail, Seattle Center Monorail, King County Water Taxi, Seattle Streetcar, Sounder Train, Community Transit and Everett Transit.

Subsidized Annual Pass Program , offers eligible riders an annual pass good on Metro and Sound Transit for 12 calendar months and is renewable each year. To qualify, you must be on one of the six following programs, Temporary Assistance for Needy Families (TANF), Housing and Essential Needs (HEN), Supplemental Security Income (SSI), Aged, Blind, and Disabled (ABD), Pregnant Women Assistance (PWA), Refugee Cash Assistance (RCA).
