Most commonly occurs while traversing a hillside with thick vegetation, ditches, manholes, loading docks and stockpiles as well as when using a chainsaw.

Bending neck up

Kneeling

Frequently on wet/slippery surfaces, uneven ground and steep slopes for up to 10 minutes at a time for up to 6 hours total in a work shift. Most commonly occurs while weeding, wrapping hoses, shoveling, using a chainsaw, posthole digging, clearing brush, performing vactor truck duties, laying pipe and ditching. The employee may be able to reduce some kneeling by alternating with bending/stooping or squatting during some duties.

Squatting

Health Care Provider initials if restricted_

Frequently on wet/slippery surfaces, uneven ground and steep slopes for up to 10 minutes at a time for up to 6 hours total in a work shift. Most commonly occurs while weeding, wrapping hoses, shoveling, using a chainsaw, posthole digging, clearing brush, performing vactor truck duties, laying pipe and ditching. The employee may be able to reduce some squatting by alternating with kneeling or bending/stooping during some duties.

Crawling

Occasionally to frequently & highly repetitive for up to 15 minutes at a time for up to 2-6 hours total in a work shift while trimming, pruning, operating a chainsaw and using a machete as well as when working on pipes and bird lines.

Reaching at waist to shoulder height

Health Care Provider initials if restricted_

Continuously & highly repetitive for up to 2 hours at a time for up to 6-8 hours total in a work shift while driving a vehicle, using a weed eater, pressure washing, and operating hand and power tools.

Reaching at knee to waist height
