

Scenario 4

Coverage for employee, spouse/domestic partner and one child

An employee has one physician office visit, the covered spouse/domestic partner has two physician office visits and the covered child has three physician office visits in 2010. The child has an operation with a stay at a local hospital. The employee fills one generic drug monthly at a local pharmacy and fills another generic drug every three months through mail-order. The spouse/domestic partner fills one preferred brand drug monthly at a local pharmacy and fills another preferred brand drug every three months through mail-order.
