

KING COUNTY BOARD OF HEALTH - 2009

The King County Board of Health is composed of ten voting members and one non-voting member. Eight of the eleven members are elected officials – three from the Metropolitan King County Council, three from the Seattle City Council and two elected officials from the Suburban Cities of King County. The three remaining members are health professionals. The health professional members serve as citizen public health experts, assisting the Board with complex, often technical, public health issues.

Under state law, this Board has “supervision over all matters pertaining to the preservation of life and health of the people within its jurisdiction.” Specific powers and duties of this Board includes: enforcement through the local health officer state public health statutes and rules; enacting local public health rules and regulations; providing for the control and prevention of infectious disease; and, establishing fee schedules for licenses, permits and other services.
