

# **NOTICE OF PUBLIC HEARING**

## **2013 Amendments to the King County Comprehensive Plan**

### **Proposed Ordinance 2013-0411**

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (Council) will hold a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse, 516 Third Avenue, Seattle, WA, on Monday, October 28, 2013, beginning at 1:30 p.m. The purpose of this public hearing is to consider adoption of Proposed Ordinance (PO) 2013-0411 (hereinafter subject legislation) adopting amendments to the 2012 King County Comprehensive Plan (KCCP).

#### **Public Hearing**

King County encourages public comment at the October 28 public hearing. Testimony is limited to two minutes per speaker. If you wish to submit written materials for the Councilmembers' review, please provide 15 copies to the Council Clerk. The chambers are equipped with an audio/visual system capable of displaying 35mm slides, VHS tapes, overheads (transparencies are not necessary), and computer displays. Audio/visual presentations are included in the 2-minute timeframe. Testimony sign-up will begin at 1:15 p.m. October 28 in the lobby outside the Council Chambers. #### **Summary**

King County adopted 2012 updates to the KCCP in December 2012. The city of Snoqualmie timely appealed to the Growth Management Hearings Board, arguing that the County's 2012 updates failed to comply with 2009 amendments to the Growth Management Act (GMA). While the Board dismissed the city's appeal in its entirety, it also determined that the KCCP did not adequately demonstrate that the updates were reviewed and potentially revised to comply with the requirements of GMA since the last major update to the KCCP in 2008. The board remanded to the County the KCCP's Introduction, Chapters 1 and 2, and Technical Appendix D to take appropriate action to show that the 2012 updates to the KCCP comply with the requirements of the GMA, including statutory amendments effective after 2008. On September 17, 2013, the Council's Transportation, Economy and Environment Committee completed its review of the subject legislation which makes revisions to the remanded portions of the KCCP to reflect how the KCCP complies with the GMA and reported it out to the Council with a "do pass" recommendation.

**Final Consideration**

Final consideration of the subject legislation shall occur after the public hearing and is tentatively planned for November 4, 2013.
