## Hi all -

I see that there's an agenda item re: the MIDD adopted budget for 2017-2018. I will not be at the meeting tomorrow, but did want to just offer a few bullet points about the council's actions:

- The Council appropriated \$1M in MIDD to support behavioral health services as part of an initiative to expand shelter capacity (the MIDD funding is in addition to reprioritized General Fund and Housing Opportunity funds). Housing/homelessness was identified by the Budget Leadership Team as one of its highest priorities.
- The Council's adopted MIDD budget and SIP removed the emerging issues appropriation authority from the base budget (\$1.3M for 2017-2018) and in the SIP indicated that emerging issues funds should be appropriated periodically throughout the budget cycle.
- The Council also reduced appropriation authority for the Communities & Consumers work group from \$250,000 to \$20,000 and in the SIP indicated that members of the work group would be reimbursed for expenses rather than compensated.
