CALL TO ORDER / INTRODUCTIONS

The Board for Developmental Disabilities meeting convened at 9:40 a.m. on Wednesday, September 7, 2016, at the 2100 Building, Community Room A. The Board

Co-Chair, Nancy Yee, called the meeting to order with welcoming remarks and self-introductions.

APPROVAL OF MINUTES

0907201601 Nancy Yee, Co-Chair called for a motion to approve the August 3, 2016, Minutes. The Minutes were so moved, seconded, and approved as written.

CHAIR'S REMARKS

Nancy Yee, Co-Chair happily announced Alice Fong is joining the Board members at the table today as a new board member. Alice is a dedicated leader committed to creating an all-inclusive community.

2017 LEGISLATIVE AGENDA DISCUSSION

Nancy Yee, Co-Chair, presented a draft of the King County Board for Developmental Disabilities' 2017 Legislative Agenda prepared by the Board's Legislative Committee. The Board's Legislative Agenda highlights a set of shared values and principles that guide the Board and focuses on the following 2017 legislative issues:

- The unserved and underserved need equitable access to services;
- Young children need early intervention services;
- Families in crisis need emergency respite and crisis stabilization services;
- Graduating young adults need employment services;
- People with disabilities need stable and equitable community-based residential services.

Community members provided feedback on the draft Legislative Agenda. Holly Woo, KCDDD, thanked the Board's Legislative Committee for their work to prepare the Legislative Agenda. A revised Legislative Agenda that incorporates the community's feedback will be presented to the Board for final approval at the October 5, 2016, meeting.

PRE-VOCATIONAL SERVICES TRANSITION

Susy Stremel, KCDDD presented an update on King County's progress with transitioning individuals from Pre-vocational services to integrated employment or Community Access services. Copies of KCDDD's visual management tools were distributed, which demonstrate monthly progress on the transition. Significant data points included:

- The number of individuals who have exited Pre-vocational services since July 2014 to date:
- Details regarding the choices (Individual Employment services, Community Access services, or leaving services) those individuals have made after exiting Pre-vocational services;

- For individuals who chose Individual Employment services, data is displayed regarding the number currently employed and their average monthly wage;
- Overall Pre-vocational service transition progress is tracked visually adjacent to King County and DSHS/DDA established timelines.

Rod Duncan, DSHS/DDA provided an overview of State Supplementary Payment Pre-Vocational Legacy Payments. These supports may be available for individuals who are not served in a DSHS/DDA residential habilitation service and have exited Prevocational services on or after September 1, 2015.

This forum will focus on improving outcomes for students with disabilities or social, emotional, and behavioral differences.

Deborah Anderson, Board member announced the gathering of Vashon Island families who will be meeting on the last Sunday of the month to discuss advocating for their students at school.

Theresa-Ann Clark, Board member highlighted how the Shoreline Police Department is rethinking their approach to people with mental health issues and cognitive disorders in crisis through the Response Awareness De-Escalation and Referral program.

Theresa is discussing the possibility of a Developmental Disabilities Board with the Seattle Police Department to help families affected by the interactions with police.
