Alice Fong, Board member thanked everyone for making the Legislative Forum a success.

Marianna Klon, Board member thanked everyone who organized the Legislative Forum and recapped an experience from her vacation to Albuquerque witnessing the great work of the School-to-Work program in other states.

Nancy Yee, Board member was thankful to complete her son's Person Centered Plan and she is looking forward to him getting a job soon.

Leo Finnegan, Chair reported on a meeting he attended with proactive parents interested in housing for individuals with disabilities in Preston.

Stacy Gillet, The Arc of King County announced the Washington Autism Alliance and Advocacy luncheon where supporters were recognized for their significant impact on the lives of individuals with autism and other developmental disabilities.

# **2016 LEGISLATIVE FORUM**

Holly Woo, KCDDD thanked everyone for their hard work and the partnership with The Arc of King County for another successful Legislative Forum. Holly also thanked Open Doors for Multicultural Families for their efforts to encourage individuals and families from diverse communities to attend the event and assistance in providing interpreter support. Approximately 550 individuals were in attendance, including, 22 legislators, 6 legislative staff, and DSHS/DDA staff.

# REQUEST FOR QUALIFICATIONS (RFQ) AND REQUEST FOR PROPOSALS (RFP) UPDATES

Scott Leonard, KCDDD announced the Technical Assistance (TA) for Adult Services RFQ process is complete. The Washington Initiative for Supported Employment has been selected as the primary TA services agency and Service Alternatives have been selected as the secondary TA services agency. The division is anticipating that a TA RFQ for Children's services will be released in 2017.

Scott also gave an update on the Crisis Diversion Housing RFQ. The Crisis Diversion Housing contract was awarded to Vadis to manage a property in South King County for the purpose of offering short-term, residential housing options for individuals with developmental disabilities in crisis and preventing their admission into high-cost institutional settings.

Jim Ott, KCDDD provided an update on the RFP strategies funded by discretionary funding to enhance outreach services in the community.

## KING COUNTY DIVISION DIRECTOR'S REPORT

Holly Woo, KCDDD reported on The Arc of Washington and the Developmental Disabilities Council's annual Legislative Notebook meeting, which was held on December 5. A summary of policy and budget issues, DSHS/DDA data charts, and budget requests, and reports for the 2017 legislative session were provided to statewide advocacy groups. Denise Rothleutner, KCDDD reported on the following topics:

- Christina Davidson, King County's Supported Employment Program Manager will be presenting at the February 9, 2017, board meeting to share King County's employment plan for hiring individuals with developmental disabilities.
- Funding for the Best Starts for Kids (BSK) strategy to prevent youth and families from becoming homeless has been awarded to several agencies throughout King County;
- Early Intervention Provider rates have been increased due to BSK funding for early intervention;
- ❖ Early Intervention team is attending the annual Zero to Three Conference, which is focused on building powerful connections necessary to support young children and their families in reaching their full potential;
- Veterans and Human Services levy meetings are being conducted around King County to gather input for the renewal of the levy in 2017, which could provide future funding/collaboration opportunities for the developmental disabilities community; and
- Acknowledged feedback received from three community members regarding the November board meeting presentation. Staff and the board will be following up on the concerns.

## **BOARD RECRUITMENT**

The Board for Developmental Disabilities is seeking residents of King County interested in serving on the board. The board is a 15-member citizen's advisory board, which provides oversight of community services for residents of the County who have intellectual/developmental disabilities, cerebral palsy, epilepsy, autism, or other neurological impairments, and their families. The board develops plans, makes recommendations on the use of available funds, and advocates for increases in state funding and improvements in services.
