Construction schedule update: Street restoration work on 17th St. S.E. continues; Traffic impacts on A St. S.E. continue on November 11 and 12


King County contractors are continuing construction on the Stuck River Trunk sewer which will provide sufficient capacity to meet Auburn's needs through 2050 and reduce the chance of sewer backups into homes and streets.

Construction Schedule Update:

Street restoration continues on 17th St. S.E. between A St. S.E. and K St. S.E.

Crews continue grinding, grading and paving activities to restore the street to City of Auburn Standards. Restoration work is expected to be complete by November 15.

Traffic restrictions and detours on A St. S.E. will continue on Nov. 11 and 12 to accommodate street restoration. Traffic will be reduced to one lane on Nov. 11 and 12 from 9 a.m. to 3 p.m. on A St. SE (see map). This work is weather dependent and may require the scheduled dates to be extended.



Please use caution when traveling through work areas. Follow flagger instructions and traffic cones and signs, plan for travel delays.

Completed Work:

- Open trench pipe installation in all three phases from A. St S.E. to K St. S.E.
- Curb and gutter restoration

WHAT TO EXPECT DURING CONSTRUCTION:

- Work hours from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas during construction
- **Continuing on Nov. 11 and 12 from 9 a.m. to 3 p.m.:**
 - One lane of traffic each direction on A St. SE
 - Detours via F St. S.E., 12th St. S.E. and 21st St. S.E. to/from A St. S.E. and 17 St. S.E.
- Parking and pedestrian restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Extra travel time through work areas
- Noise and other activity typical of a construction site: work crews, dust, trucks, heavy machinery and equipment
