Crews to begin excavating bore pit on Southeast 264th Street

King County contractors are continuing construction on the Kent East Hill Diversion pipeline. Crews began construction of the new pipeline April 2013. The new sewer pipe will provide sufficient capacity to meet Kent's needs through 2050 and reduce the chance of sewer backups into homes and streets.

CONTINUING AND UPCOMING WORK

Pipeline installation continues. The week of June 17, crews will begin excavating a launch bore pit to prepare for trenchless pipe installation on the west portion of Southeast 264th Street (see map). Crews are continuing open trench pipe installation east of the bore pit.

Crews will begin trenchlessly installing the pipeline under the road from the pit towards school property the week of June 24. Work on school property will begin June 25.

Settlement monitoring. Precondition inspections have been completed on properties and settlement monitoring points installed. Settlement monitoring on properties along Southeast 264th Place will continue through construction.



Expect lane restrictions and limitations to parking in work areas along Southeast 264 Street. Please use caution in work areas and follow posted traffic signs and flaggers.

WHAT TO EXPECT DURING CONSTRUCTION:

- Work will occur from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas during construction
- Parking and pedestrian restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Extra travel time when driving through the work area
- Noise and other activity typical of a construction site: work crews, dust, trucks, heavy machinery and excavating equipment


