

Trenchless pipe installation continues on Southeast 264th Street

King County contractors continue to install the Kent East Hill Diversion pipeline underneath SE 264th St. The new pipeline will help provide sufficient capacity to meet Kent's needs through 2050 and reduce the occurrence of sewer backups into streets and homes.

CONTINUING WORK

• Trenchless pipe installation

Crews are midway through installing the new pipeline. Pipe installation began at the bore pit, is progressing east, and will end on school property at the tunnel receiving pit (*see map*).

Pipe installation on SE 264th St is expected to continue through the fall.

- Settlement monitoring inspections on SE 264th Pl will now occur once a week Residents on SE 264th Pl should continue to keep their property accessible during construction hours.
- Work on school property Crews will be on school property this fall to retrieve the tunnel boring machine and temporarily restore the area. The remaining pipe installation and final restoration may occur next summer.



Expect lane restrictions and parking limitations in work zones along Southeast 264th Street. Please use caution and obey flaggers and posted traffic signs.

WHAT TO EXPECT DURING CONSTRUCTION:

- Work hours from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas
- Parking and sidewalk restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Increased travel time when driving through the work area
- Noise and other activity associated with a construction site: work crews, dust, trucks, heavy machinery and excavating equipment


