INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT

Pursuant to Ch. 39.34 RCW and other applicable laws, Snohomish County, herein called the County and King county, a municipal corporation or other public agency, herein called King County, agree as follows:

1. King County agrees to extend its contract and rights to purchase the following:

Police Vehicles

(or as stated on Exhibit A attached hereto) from

Bjorklund Chrysler Plymouth, herein called the supplier.

2. The County shall submit its purchase order for product to the Supplier which shall deliver directly to the County.

3. This contract shall create no obligation to purchase any particular quantity or type of product, nor create any assurance, warranty or other obligation with respect to supplying, delivering, or condition of any product or otherwise.

4. The County shall pay for products ordered by it in the manner requested by the Supplier, and will indemnify and hold King County harmless from any liability on the purchase price of any products purchased by it.

5. This agreement shall continue in force until cancelled by either party, which cancellation shall be effected upon receipt by one of the parties of the written notice of cancellation of the other party.

6. No separate legal or administrative entity is intended to be created pursuant to this agreement. No obligation, except as stated herein, shall be created between the parties or of the supplier.
