1. **Welcome/Let's Connect.** The meeting was called to order at 12:38 p.m. by Co-Chair David Baker who then turned the floor over to Consultant Ann Macfarlane of Jurassic Parliament, who guided meeting participants in an icebreaker exercise.
2. **Review of Minutes.** The committee adopted the minutes from May 26, 2017, as corrected.

- c) A brief discussion ensued about the Muckleshoot shooting of Renee Davis.

6. Additional Ideas and Concerns

- a) Committee member Mia Gregerson invited a brief discussion concerning 40-hour versus eight-hour Critical Incident Training and training quality and how the committee would make its recommendations known.
- b) Mia also raised concerns about conducting outreach in communities with undocumented immigrants who might be fearful of any contact with government in the current political climate.
