Waxaan halkan ku caddaynayaa in guriga ku yaala lambarka dhulka ee kor ku xusan uu yahay hanti amaanad (asset of trust). Waxaa taa dheeraad u ah, waxaan caddeynayaa in amaanadda (trust) ay buuxineyso shuruudaha mulkiilenimada sida lagu qeexay ee hoosta yimaada (**calaamadeed mid**):

- WAC 458-16A-100(21)(a)- Codsaduhu wuxuu qabsaday guri noolasha markii uu hantida u wareejijo amaanada ama hanti/guri nolosha kadib markii dambena ay muujisay warqad hanti. Ku soo lifaaq nuqul ah warqada hantida.
- WAC 458-16A-100(21)(b) - Codsadaha waa "Deganaha" ama abuuraha amaanada (trust) (dib looga qaadi karo ama aan dib looga qaadi karin) iyo uu naftiisa/nafteeda ku qoray/ku qortay. ka-faa'iideystaha danaha ee guriga assaasiga ah, ama qeybtan gaarka ah ee amaanada (trust), iyo in ka faa'iidaysiga danaha soconayo ugu yaraan noloshiisa/nolosheeda oo dhan.
- WAC 458-16A-100(21)(c) – Amaanada (trust) waa mid aan dib loo qaadi karin oo cadsaduha ayaa ah ka-faa'iideystaha. Isaga / iyadu waxaa la siiyay ka-faa'iidaysiga danta ee qaybta guriga assaasiga ah ee amaanada (trust) ugu yaraan noloshiisa/nolosheeda oo dhan.

## TILMAAMAH

### Fadlan la xiriir Xafiiska Qiimeeyaha Degmadaada wixii caawimaad ah si aad u buuxiso foomkan.

Ma jiro wax qodob ka mid ah sharciga ee u oggolaanaya mulkiileha isagoo u maraya amaanada (trust) ee ujeedooyin ah inuu buuxiyo shuruudaha Barnaamijka Ka Cafinta Canshuurta Guryaha ee loogu talagalay Dadka Waaweyn iyo kuwa naafada ah.

Si loo go'aamiyo in shuruudaha mulkiilenimada la buuxiyey marka hantida ay tahay hantida amaanada (trust), waa inaad bixisa nuqul ah amaanada (trust) (ama qeybahaa amaanada) oo caddaynaya in shuruuda mulkiilenimada la buuxiyey.

Waxaad buuxin kartaa foomkan naftaada ama waxaad ka codsan kartaa caawimo qareenkaaga.

**RCW 84.36.381(2)** wuxuu leeyahay, si uu ugu qalmo ka cafinta canshuurta, codsadaha waa in uu layhay guri wakhtiga fayl-gareenta "lacag ahaan ah, sida u ah hantida/guriga nolosha, ama iibsiga qandaraaska". Wuu kaloo sheegayaa in heshiiska kirada ee nolosha oo dhan loo aqoonsan doono guriga nolosha.

Sidaa darteed, si loo buuxiyo shuruudaha mulkiilenimada ee loogu talagalay barnaamijkan ka cafinta canshuurta hantida/guriga markii hantida ay tahay hanti amaanad (trust), Amaanaddaa waa in ay muujisaa danta "guriga nolosha" ee guriga uu yahay mid loo cafiyey qofka codsanaya ka cafinta canshuurta. Si loo buuxiyo shuruudahaa:

- guriga noloshada waa in uu ahaa wax uu qabsaday qofka codsanaya ka cafinta canshuurta markii hantida loo wareejiyay amaanada (trust); **AMA**
- danta hantida nolosha waa in mar dambe muujisay warqad hanti qofka codsanaya ka cafinta canshuurta; **AMA**
- amaanada waa in ay ku jirtaa luqad muujineysa danta guriga nolosha ee deganaanshaha si looga dhaafu qofka codsanaya ka cafinta canshuurta.

#### WAC 458-16A-100 (19), (21), iyo (22) caddaynaya shuruudaha lahaanshaha:

(19) **Heshiiska ah nolosha oo dhan.** "Hashiiska ah nolosha oo dhan" waxaa loola jeedaa heshiis kiro ah oo joogsanaya marka qofka ijaartay uu dhinto.

(21) **Guriga nolosha** "Guriga nolosha" waxaa loola jeedaa guri muddadiisu ay ku egtahay nolosha qofka haysta ama qof kale.

(a) Qabsashada guri nolosha si u ah degaanka assaasiga ah ee la galley amaanad (trust) ama lagu wareejiyey mid kale waa guri nolosha.

(b) Ka faa'iidaysiga danta ee amaanada (trust) waxaa loo tixgeliya guri nolosha ee daganaha ee amaanada (trust) aan dib looga qaadi karo ama aan dib looga qaadi karin oo uu naftiisa/nafteeda u siinayo ka faa'iidada toos ahaan ee degaankiisa/gurigiisa assaasiga ah, ama qeybta amaanada (trust) ee ku jira gurigiisa/degaankiisa shakhs ahaaneed, ugu yaraan muddada noloshiisa ama nolosheeda oo dhan.

(c) Ka faa'iidaysiga danta ee amaanada (trust) ee dib loo qaadi karin waxaa loo tixgeliya guri nolosha, ama heshiis nolosha oo dhan ah ee ka faa'iidaystaha la siiyay ka faa'iidaysiga danta ee matalaya gurigiisa/gurigeeda asaasiga ah ee loo haysto amaanad (trust) aan laga qaadi karin, haddii ka faa'iidaysiga danta la siiyo ee hoos yimaada qalabka amaanada (trust) muddo aan ka yareyn nolosha ka faa'iidaystaha oo dhan.

(22) **Lahaansho.** "Lahaansho" waxaa ka mid ah "iibsashada qandaraaska" iyo sidoo kale "lacag ah", "guri nolosha," iyo wixii ah "heshiis kiro oo nolosha oo dhan ah". Guri ay layhiin bulsho is qaba ama guri la wadaaga guriga ama uu layhay la-dagane waxaa loo arkaa in uu leeyahay lamaane walba ama guri la wadaage walba ama guri la-dagane walba.
