Dr. Fleming discussed a proposal for coal export to China through ports in Oregon and Washington. King County Public Health and City of Seattle have provided funding to Washington State University, University of Washington and Oregon Health Policy Institute to conduct a Health Impact Assessment to evaluate both potential health benefits and risks of this proposal.

Dr. Fleming also reported on a new strain of influenza in China called H7N9. There have been over 100 cases of this new type and it has a high mortality rate. The good news is the virus does not have the ability for sustained person to person transmission. As summer approaches, the flu season is expected to slow down, but they will carefully watch for the reemergence of this strain as fall approaches. To date this strain has not appeared here.

Dr. Fleming congratulated Ben Leifer, Chief Administrative Officer, on his retirement after 33 years of service.
