Sponsors

1 A RESOLUTION approving scope of project changes for
2 the Healthcare for the Homeless grant.

3 WHEREAS, the Board of Health is the formal governance board for the Public
4 Health - Seattle & King County Health Care for the Homeless grant under section 330(h)
5 of the Public Health Services Act, and

6 WHEREAS, the Board of Health is responsible for reviewing and approving what
7 are known as "Change in Scope of Project" requests and documenting these approvals in
8 the Board minutes;

9 NOW, THEREFORE, BE IT RESOLVED by the Board of Health of King
10 County:

11 The board approves the following Scope of Project changes:

12 A. At the end of 2013, Women, Infants and Children and Maternity Support
13 Services programs will move from Renton Public Health Center location to a site on the
14 Renton Technical College campus. The move will also relocate the Public Health Renton
15 Dental Clinic from leased space near the Valley Medical Center campus to shared space
16 in the building at the Renton Technical College; and

17 B. Public Health - Seattle & King County will relocate two programs now
18 located at Renton Public Health Center: the Family Planning program will be moving to

19 the new Kent PHC site and the Nurse Family Partnership program will be relocating into
20 unoccupied space at the Federal Way Public Health Center; and

21 C. Public Health - Seattle & King County is in the final processes of selecting a
22 new location for the Kent East Hill Women, Infants and Children, Maternity Support
23 Services and Nurse Family Partnership programs, along with the Family Planning
24 program, which will be relocating from Renton Public Health Clinic. The timeline for
25 this move is anticipated to be end of 2013; and

26 D. Salvation Army William Booth Center located at 811 Maynard Ave S, Seattle
27 WA 98134-1324 will be removed from the Public Health - Seattle & King County,
28 Health Care for the Homeless Network scope of project, effective January 2, 2013; and

29 E. Ballard Homeless Clinic, operated by Neighborcare Health, will maintain a
30 temporary location at 5710 22nd Avenue NW, Seattle, WA 98107 until March 2013. At

31 that time the Ballard Homeless Clinic will move to its permanent location at 1753 NW
32 56th ST Seattle, WA 98107-5223.


