Public Health – Seattle & King County is releasing preliminary data of COVID-19 confirmed cases by race/ethnicity. Additional data is needed to be able to draw conclusions about the impact COVID-19 is having across demographic groups in King County and information will be released once data is available.

Washington State Department of Health attempts to contact every person who tests positive for COVID-19 for a case interview, during which they ask about race/ethnicity. However, DOH is not able to reach and conduct full interviews with everyone. Locally, PHSKC is augmenting this data through complementary databases to have a more in-depth understanding of how COVID-19 is impacting our community. Currently, we have race/ethnicity data for about 51% of confirmed cases, limiting the generalizability of conclusions from this subset of cases.

All data is preliminary and is subject to change as updates are made available and new cases are reported. Included in this release is race and ethnicity data for all confirmed COVID-19 cases reported to PHSKC as of April 10, 2020 10:00 AM. Information regarding hospitalizations and demographics will be updated once available.

#### **Executive Summary:**

A limitation of the data is that race/ethnicity is available for only 51% of cases. In addition, the availability and distribution of testing throughout the community may limit the generalizability of conclusions drawn from these estimates. Please use caution in interpreting the data because of the small sample sizes (particularly among some race and ethnicity groups), availability of testing, and missing data.

#### Among confirmed cases:

- Through April 10, 2020, there have been 4053 confirmed cases (182.1 cases per 100,000 King County residents). The rate of confirmed cases is highest among non-Hispanic Native Hawaiian or Pacific Islanders (189.5 per 100,000) and Hispanics/Latinos of any race (159.2 per 100,000 King County residents), and is significantly higher relative to non-Hispanic Asians (68.8 cases per 100,000 King County residents), non-Hispanic Blacks (109.3 per 100,000 King County residents) and non-Hispanic Whites (93.7 per 100,000 King County residents). There are no statistically significant differences in rates among other race and ethnicity groups.
- The proportion of confirmed cases among Hispanics/Latinos of any race (17.1%) is higher relative to the relative distribution in the total King County population overall (10%).

## Among hospitalized cases:

- Through April 10, 2020, 646 cases have been hospitalized (15.9%). There are no statistically significant differences in hospitalization by race/ethnicity.
- A limitation of the data is that race/ethnicity is available for only 63% of hospitalized cases. A small sample size limits the reliability of comparisons across race/ethnicity.

#### Among deaths due to COVID-19:

- Through April 10, 2020, 274 cases have died (6.8%). The rate of death is highest among non-Hispanic Whites (14.6 deaths per 100,000 King County residents), and is significantly higher relative to non-Hispanic Blacks (7.7 deaths per 100,000 King County residents) and Hispanics/Latinos of any race (6.3 deaths per 100,000 King County residents). There are no statistically significant differences in rates among other race and ethnicity groups.
- A limitation of the data is that a majority of deaths occurred among people living in long-term care facilities, where the population distribution by race/ethnicity may not represent the general population. Additionally, this population may be at higher risk due to advanced age and underlying medical conditions. A small sample size limits the reliability of comparisons across race/ethnicity.
