## Operating permits

- Poultry retailer.....\$320.00
- Pet food retailer\* .....\$221.00
- Pet shop - aquarium only.....\$241.00
- Pet shop – standard .....\$418.00
- Pet daycare.....\$341.00
- Commercial kennel.....\$341.00
- Pet grooming service .....\$241.00
- Mobile pet grooming service 1 vehicle.....\$241.00
- Mobile pet grooming service - each additional vehicle with one owner inspected at the same time and place..... \$81.00
- Animal shelter category 1 <1,500 adoptions/year.....\$418.00
- Animal shelter category 2 >1,500 adoptions/year .....\$892.00
- Animal shelter category 3 \*\* satellite adoption facility per location .....\$146.00
- Animal shelter category 4 <500 adoptions/year -- only small, non-canine and non-feline mammals (e.g. ferrets, rabbits, hamsters, hedgehogs, gerbils, chinchillas, rats, mice).....\$250.00

## Plan review

- Plan review fee for new construction.. \$184.80 base fee +\$184.80/hour after 1 hour
- Plan review fee for conversion of existing construction ..... \$184.80 base fee +\$184.80/hour after 1 hour
- Plan review fee for remodel of existing facility ..... \$184.80 base fee +\$184.80/hour after 1 hour
- Two or more plan reviews for one facility..... \$184.80 base fee +\$184.80/hour after 1 hour
- Plan resubmitted ..... \$184.80/hour

**Plan review (continued)**

- Subsequent pre-operational inspections, on-site inspection before plan submittal, or on-site inspection when plan review not required ..... \$184.80 base fee +\$184.80/hour after 1 hour

**Miscellaneous fees**

Variance request.....\$184.80

**Fees based on percentage of applicable annual permit**

- Re-inspection fee.....50%
- Reinstatement of permit after suspension ..... 100%

Other ..... \$184.80/hour

---

When a business offers more than one type of service, they pay for the highest fee permit as the base fee and \$241 one additional service or \$482 for two or more additional permit classifications.

\*Exemptions - Pet food retail business permit fee shall be waived for any holder of a current pet shop, commercial kennel, pet daycare facility, animal shelter or pet grooming service permit.

\*\*Satellite pet adoption locations must be co-located with a permitted pet shop, commercial kennel, specialty pet food retail business or pet grooming service in order to qualify as a "satellite adoption facility." If the adoption service is a "stand alone" facility – i.e., not co-located with another type of pet facility – it would not qualify as a "satellite adoption facility," but would be classified as a Category 1 (performing up to 1500 pet adoptions per year) or Category 2 (performing over 1500 pet adoptions per year) animal shelter.
