### 1. Key indicators of COVID-19 activity

The following chart includes King County data aligned with key indicators of COVID-19 activity outlined in the document titled <u>Tools to Prepare for Provision of In-Person Learning among K-12 Students at Public and Private Schools during the COVID-19 Pandemic released by the Washington State Department of Health (DOH). #### 3. Seattle utility discount program

Please share with your Seattle-based networks! The City of Seattle can help people who are struggling to pay their electricity and utilities bills. Eligible households can enroll in the City of Seattle's Utility Discount Program (UDP), which offers a 60% discount on Seattle City Light bills and a 50% discount on Seattle Public Utilities bills. To be eligible, pre-tax household income must be at or below 70% of the state's median income.

<sup>&</sup>lt;sup>3</sup>Percent of COVID-19 tests with positive results over the past 14 days—WA State Department of Health has resumed reporting on negative laboratory results. There remains a large backlog of negative lab results that have not been processed (about 100,000 negative lab results). The count of people tested and all test results is underestimated as WA DOH processes this backlog. As a result, the test positivity reported on this dashboard are overestimated, especially in the most recent week.

- Complete the online enrollment form
  - The form is in English. For language support, call 206-684-0268 to speak to a representative.
- Applications will be reviewed and processed. If an application meets the eligibility requirements, the household will be enrolled. (The response email or letter may be in English.)
- The discount may take up to **two** billing cycles to appear on bills.
- Customers approved for receiving the discount will need to renew their application with income documentation six months after their approval date.
