Resuscitation Academy

The Resuscitation Academy, a partnership of King County EMS and Seattle Medic One, is holding a 2-day symposium on strategies to improve cardiac arrest survival rates. Over 100 participants from around the country will gather at Harborview May 16-17 for a series of lectures and demonstrations led by Drs. Leonard Michael Copass, Mickey Cobb, Eisenberg, and Tom Rea. Attendees will be given the knowledge and essential tools to return to their communities and develop a concrete plan of action to improve survival. <u>Cardiac Arrest Registry to</u> <u>Enhance Survival (CARES)</u>

Complete, accurate, and information is integral to management of all aspects of the Emergency Medical Service (EMS) system in King County, but most specifically Out of Hospital Cardiac Arrest (OHCA) data. Washington's Cardiac Arrest Registry to Enhance Survival (WACARES) is a secure, Web-based data management system in which participating communities enter local data and generate reports. Thanks to a grant from the Medtronic Heart Rescue Foundation. Washington is launching a statewide effort to collect OHCA Participation allows the State of Washington to be part of a national effort in cardiac arrest surveillance and improvement. King County has been a front runner in cardiac arrest surveillance and our involvement in CARES will strengthen this national effort. Quickly implementing the "chain of survival" is crucial to surviving OHCA. but many communities cannot measure how effectively EMS providers activate the chain. Without adequate performance measures, these communities lose opportunities to improve emergency cardiac care and save lives. King County has participated in a Cardiac Arrest Registry for over 30 years, and registry (Cardiac Arrest Surveillance System) has allowed us to measure and improve out-ofhospital cardiac arrest and resuscitation.

By using WACARES, local agencies outside of King County will now have a platform to collect data, run reports, and use data for quality improvement and targeted programs to improve resuscitation. Communities can compare **EMS** their system performance to de-identified aggregate statistics at the local, regional, or national level discover promising practices that could improve emergency cardiac care.
