#### 1095-B

The 1095-B is a tax form verifying you or your household member received Washington Apple Health (Medicaid) coverage for one or more months of the previous tax year.

Starting in the 2020 tax year, Health Care Authority (HCA) will no longer mail the 1095-B forms.

Individuals with a <u>Washington Healthplanfinder</u> account will be able to view and print their 1095-B tax form in the Message Center of their dashboard.



Updated Family Planning Only application (13-781)

### State Family Planning only application

- ▶ In the 2019-20 legislative session, <u>SB 5602</u> was passed to help reduce barriers to reproductive health care for all, and expanded family planning to all non-citizens that do not qualify for the federal family planning program.
- People can apply for this program through family planning providers or by contacting HCA.



### State Family Planning only application

The purpose of the family planning only program is to provide family planning services to:

- Improve access to family planning and family planningrelated services;
- Reduce unintended pregnancies; and
- Promote healthy intervals between pregnancies and births.

A client must meet the qualifications for either the state or the federal funded program to be eligible for family planning.
