CALL TO ORDER

- 1. Welcome & Introductions
 Jeff Sakuma welcomed members to the meeting of the HCHN Governance Council (GC). Full quorum present.
- 2. Minutes

GC members reviewed the minutes from the 6/15 meeting. Kristina Sawyckyj made motion to approve the minutes, Leslie Enzian seconded; vote was unanimous in favor of the motion.

PUBLIC COMMENT

There was no public comment.

HCHN GOVERNANCE COUNCIL: COVID-19 HOMELESSNESS RESPONSE PLANNING SERIES [PART 2]

1. Community Needs/Gaps/Inequities

Lee Thornhill grounded members in the key takeaways from the 6/15 GC meeting then Zsa Zsa Floyd facilitated a discussion focused on the following questions:

- It's July and reaching 80 degrees. How we can strategize to help people living off the grid concretely get more water, food and coffee this summer?
- What is getting in our way and how can people in leadership positions help?

GC members shared thoughts on the key needs/gaps for people living unsheltered.

REGULAR AGENDA AND BOARD PROCESS

1. HCHN Admin Updates

Denise Hawthorne shared information on the current King County response to the COVID-19 outbreak. Members were referred to the COVID-19 Homelessness Response webpage, which includes information on all upcoming meetings, to stay updated.

She also shared updates on the new highly impacted communities (HIC) strategy, that will move forward despite the larger RFP process being put off by a year. The original \$150,000 designated for HIC can still be put out for bid for work to be contracted with a new qualifying agency in 2021, with the intent to continue contracting with that agency through the next HRSA project period (2-3 years expected).

Denise and Katherine King will join the August meeting to present on the budget that will be submitted for HRSA's Budget Period Renewal (BPR), due in early September.

- 2. HCHN Committee Updates and Actions
 - a. Community Advisory Group (CAG)

The CAG was updated on the current King County response to the COVID-19 outbreak. There is also a new membership application process to update the roster for GC approval. The CAG letter on hygiene and hydration needs approved by the GC at the 5/18 meeting, was sent out. Members also reflected on the issues related to CHOP/CHAZ, the recent protest area on Capitol Hill focused on racial justice.

b. Executive Committee (EC)

There is one open slot on the EC for the GC member-at-large. Anyone who is interested should reach out to Rekha. Members were also encouraged to reach out to any connections who may be interested in representing East King County on the GC.

c. HCHN Racial Equity Workgroup

The HCHN Racial Equity Workgroup met to discuss opportunities to advance equity and social justice and support the HCHN Admin Team in its efforts. The workgroup will meet monthly, with their next meeting on Tuesday, August 11; new members welcome.

PUBLIC COMMENT

Harold Odom expressed a need to also support pets in staying healthy during extreme heat events.
