Monday, January 11 2021 Zoom Meeting

## **CALL TO ORDER**

1. Welcome & Introductions
Kristina Sawyckyj welcomed members to the meeting of the HCHN Governance Council (GC). Full quorum present.

2. Minutes

GC members reviewed the minutes from the 12/21 meeting. Jesus Rodriguez made motion to approve the minutes, Janice Tufte seconded; vote was unanimous in favor of the motion, with Eleta Wright, Katherine Switz, and LaMont Green abstaining.

#### **PUBLIC COMMENT**

There was no public comment.

#### REGULAR AGENDA AND BOARD PROCESS

- 1. HCHN Admin Update
  - a. Staffing Updates

Denise Hawthorne shared that the initial workgroup is still in the process of reviewing applications and conducting screening interviews to determine which candidates to move to the next stage. She noted that there will be opportunities for GC/CAG members to participate in interviews, with the recognition that not everyone can be included. However, HCHN will plan a special meeting scheduled closer to the end of the process to give GC/CAG members an opportunity to engage with the final candidate(s) and offer feedback for consideration.

Denise also requested member input to help identify specific topics to include as interview questions, and encouraged members to share any thoughts with Rekha Ravindran by 1/19.

# b. COVID-19 Homelessness Response

Jody Rauch shared updates and answered questions related to the COVID-19 vaccination roll-out, including information on the new <u>King County community distribution programs</u>. She also noted that the COVID teams are hiring new staff to support programs.

Rekha also noted a recent increase in Shigella cases. Members were directed to an educational <u>flyer</u> and Public Health Insider <u>blog post</u> for more information.

# 2. HCHN Committee Updates and Actions

a. Community Advisory Group

Zsa Zsa shared that Dr. Mia Shim and Jody joined the meeting to share more information about COVID-19 vaccine planning and solicit feedback from members.

#### b. Executive Committee

The EC discussed developing an anti-harassment policy and future topics to bring to the GC.

# c. Racial Equity Workgroup

Eleta shared that the workgroup is focusing on the Network priority related to hiring, recruitment, and retention, and plans to present more updates at the March GC meeting. Regular meetings are the second Monday of each month, 9-10:30am.

# 3. Open Forum

Members discussed flu rates in King County, and were directed to the influenza dashboard.

Leslie Enzian suggested restarting the other GC workgroups as COVID restrictions relax. Katherine mentioned that the Behavioral Health is continuing to meet, and regular meetings are the fourth Monday of each month, 10-11am.
