






Planning Timeline

Jurisdiction Input

- Improve connections to centers and high capacity transit services
- Increase access to park-and-rides
- More investment in alternative services, for low density and hard-toserve areas
- More east-west connectivity
- Frequent service key for areas with growth
- Express service from more rural cities






Draft Preliminary Concept

- Countywide, 70% of people and 82% of jobs are within ½ mile of frequent service
- Countywide, 87% of transit users are expected to reach transit by biking or walking
- Countywide transit trips increase 125% with an increase in service hours of 66%
