STIPULATION AND AGREED ORDER OF DISMISSAL

COMES NOW petitioner, General Biodiesel Seattle, LLC ("General Biodiesel"), by its attorney, Ame Lewis of Davis Wright Tremaine LLP, and respondent, King County, through its Wastewater Treatment Division, ("Division"), by the King County Prosecuting Attorney's Office, Michael Graves, Deputy Prosecuting Attorney, and agree and stipulate to the following:

1. On May 14, 2020, the Division, through its Industrial Waste Pretreatment Program, issued an Assessment of Penalty, Compliance Order, and Determination of Significant Noncompliance to General Biodiesel, based on a Notice of Violation (NOV) issued to General Biodiesel on August 26, 2019.

2. Following the denial by the Division of General Biodiesel's request for reconsideration of the Assessment of Penalty Notice and Compliance Order, General Biodiesel filed its Statement of Appeal, dated September 17, 2020, with the Office of the King County Hearing Examiner, pursuant to K.C.C. 28.84.100.

3. In order to settle the dispute between General Biodiesel and the Division, the parties agree to the terms and conditions set forth below.

4. For the purposes of settlement, and to resolve violations described in the Assessment of Penalty Notice and Compliance Order, General Biodiesel agrees to pay a penalty of \$11,500, with total amount due and paid in full within 30 days of executing this agreement.

The parties acknowledge that one alleged violation involves an alleged discharge which interfered with publicly owned treatment works operations defined under King County Code 28.82.810 as significant noncompliance. Pursuant to 40 CFR 403.8 and K.C.C. 28.84.060, the Division will publish, in a newspaper of general circulation, General Biodiesel in a list of industrial users determined to be in significant noncompliance. The Division agrees to use the following publication to describe the enforcement action:

Violations Resulting in Significant Non-	Reason for Publication and
Compliance (SNC) status and/or Penalties	Additional Comments
General Biodiesel – Seattle CODE VIOLATIONS: A Notice of Violation was issued for 1) Discharge of process water containing fats, oils, and grease (FOG) to the sanitary sewer, which obstructed the sewer and caused a sewer overflow and 2) failure to obtain written approval for the discharge of process water containing FOG from the facility.	General Biodiesel was issued a penalty, post violation charges and a compliance order. A determination of SNC was made for causing interference with the sewer system. This enforcement action was appealed by the company and a settlement was reached. As part of the settlement, General Biodiesel does not admit to any wrongdoing.

8. The execution of this Stipulation and Agreed Order of Dismissal shall constitute the Division's full and complete satisfaction and release of all claims described in the Assessment of Penalty, Compliance Order, and Determination of Significant Noncompliance Notice, and for any violations that may have occurred prior to the date of execution of this Stipulation and Agreed Order of Dismissal.

9. This Stipulation shall constitute an agreement of the signatory parties only, and the parties agree that it shall confer no rights or benefits on any other person or entity.

10. The parties shall have the right to enforce the requirements and conditions of this Stipulation and Agreed order of Dismissal in the Superior Court of King County, to the full extent permitted by law.

11. The parties further agree that this matter shall be dismissed with prejudice, with each party to bear its own attorney's fees and costs; provided, however, that either party shall have the right to enforce this Stipulation and Agreed Order of Dismissal upon the terms and conditions described above.
