

4 Amend Map #14, Section 25, Township 23, Range 05, as follows:

6 Redesignate the following parcels from Rural Residential to Urban Residential, Low and add
7 them to the Urban Growth Area:

9 • 2523059050

10 • 2523059086

12 Amend all other KCCP and Technical Appendix maps that include the Urban Growth Area to
13 be consistent with this change.

14

15 **Effect:** This amendment would redesignate 42.5 acres of land from RA to Urban
16 Residential, Low.

8 Amend Map #14, Section 25, Township 23, Range 05, as follows:

10 Reclassify the following parcels from RA- 2.5 (Rural, one lot per 2.5 acres) and RA-2.5
11 SO (Rural, one lot per 2.5 acres and SO-180) to R-1-P (Residential, one lot per acre) and
12 R-1-P-SO (Residential, one lot per acre, and site specific conditions and SO-180):

15 • 2523059086

17 Apply the following property-specific (p-suffix) condition:

19 1. Except as provided in subsection 2., the use of the property shall be limited to a
20 school, as provided under the purchase agreement with the US Department of
21 Education, under the provisions of Section 203(k)(1)(a) of the Federal Property
22 and Administrative Services Act of 1949.
23
24 2. Any revisions to the legally established sewer infrastructure that currently
25 traverses the property shall be sized and designed to serve only the needs of
26 development for school purposes.
27
28 3. If a new vehicular access to the school property is proposed through King
29 County-owned open space, it shall be allowed only if:
30
31 a. The current access by way of an existing easement through said King County-
32 owned open space is vacated,
33
34 b. The location of new easement results in a net benefit to the function of the
35 King County-owned open space than the current easement, and
36
37 c. The entrance of the new vehicular access results in less impacts to residential
38 neighborhood local access streets than the current access.
39

40 Retain the provisions of SO-180 (Wetland Management) on the portions of these parcels
41 where such provisions currently apply (see attached map).
42

43 **Effect:** This amendment would rezone 42.5 acres of land from RA 2.5 and RA 2.5 SO to
44 R-1-P and R-1-P-SO and would apply development limitations and retain the current SO
45 provisions.
