### 2020 BOND PROGRAM GOALS


- Construct a new inpatient tower with parking

#### **ACCOMPLISHMENTS**

- Provided a blocking and stacking workshop and process overview to King County agencies on the Harborview campus; participants included the Medical Examiner's Office, Involuntary Treatment Act Court, Sexual Health Clinic, Tuberculosis Clinic, and King County lab
- Awarded a \$50,000 grant from King County's Office of Equity, Racial, and Social Justice to support translation services and multi-lingual materials for the Bond Program

### **UPCOMING ACTIVITIES**

- Awaiting the Implementation Advisory Committee's (IAC) letter and recommendations, expected in September 2023
- Finalizing Project Management Plans
- Convening an Environmental Impact Statement (EIS) work session where King County will have the Prosecuting Attorney's Office, and additional land-use counsel review the impacts and alternatives in the EIS. The EIS supports the MIMP amendment, and King County will review alternatives that align with the MIMP goals

#### **Update**


- Launching the campuswide infrastructure analysis led by the prime consultant OAC


#### Update

- Developing a collaborative technology solution to capture and manage input coming from various sources to support the procurement process




# COSTS AND SCOPE ANALYSIS
