I voluntarily and knowingly agree to reset the commencement date to the next court hearing (scheduled above). I agree that my new time for trial expiration date is 60 days from that date if I remain in custody on this case, or 90 days from that date if I am released on this case before the expiration of 60 days.

The time for trial waiver must be checked if a new Case Scheduling hearing date is set or if a plea date is set more than one week from today's date.

I have informed my client of the next hearing date and I have explained the waiver of time for trial if it applies.
