

Configuración para una nueva estación de reciclaje y transferencia de basura en el sur de King County

King County ha publicado un estudio preliminar de la Declaración de Impacto Medioambiental EIS (siglas en Ingles) que evalúa los impactos medioambiental potenciales al configurar, construir y hacer funcionar una nueva estación de transferencia y reciclaje en el sur de King County, con el fin de remplazar la existente estación de transferencia de Algona. Se están evaluando las tres siguientes alternativas:

Ninguna medida alternativa: 35315 West Valley Highway South, Algona (estación de transferencia de Algona actual)

Alternativa 1: 901 C Street SW, Auburn

Alternativa 2: 35101 West Valley Highway South, Algona - alternativa preferida

El lunes 22 de febrero de 2016, se llevará a cabo una reunión de las 6 a las 8 p. m. en Auburn High School Commons, 711 East Main Street Auburn, WA 98002. En caso de necesitar arreglos especiales favor de llamar al 206-477-4466 una semana antes de la reunión.

킹 카운티 남부에 새로운 재활용 및 쓰레기 전송역 위치 선정

킹 카운티는 기존의 알고나 전송역 (Algona Transfer Station)을 대체하는 새로운 재활용 및 쓰레기 전송역의 위치를 선정하고 건설하고 운영하는 것의 환경영향을 평가하는 환경 평가 진술서 (EIS) 초안을 발표했습니다. 다음 3가지 대안이 평가되고 있습니다:

아무 것도 하지 않는 대안 – 35315 West Valley Highway South, Algona (기존의 알고나 전송역)

대안 1 – 901 C Street SW, Auburn

대안 2 – 35101 West Valley Highway South, Algona (선행되는 대안)

Администрация округа Кинг опубликовала предварительный вариант Заявления о воздействии на окружающую среду (ЗВОС), в котором производится оценка потенциального воздействия на окружающую среду выбора местоположения, строительства и эксплуатации новой станции переработки и перевалки отходов в южной части округа Кинг на замену существующей станции перевалки отходов в г. Алгона. Дается оценка трех альтернативных вариантов:

Вариант без изменений – 35315 West Valley Highway South, Algona (г. Алгона, существующая станция перевалки отходов)

Вариант 1 – 901 C Street SW, Auburn (г. Оборн)

Вариант 2 – 35101 West Valley Highway South, Algona (г. Алгона, предпочтительный вариант)

Proponent/ Lead Agency: King County Department of Natural Resources and Parks, Solid Waste Division (the Division)

Issuance date: February 4, 2016

Project Description: The project will site, design, construct and operate a new solid waste recycling and transfer station in south King County to replace the existing Algona Transfer Station. The existing station was built about fifty years ago, is over-capacity, has no space for recycling, and uses outdated technology. The *Solid Waste Transfer and Waste Management Plan*, which was the result of a regional, multi-year planning effort, recommended replacing the Algona Transfer Station with a new south county station. The new station will serve the areas surrounding and communities of Algona, Auburn, Federal Way and Pacific, providing solid waste transfer and recycling services for the next 50 years.

Draft Environmental Impact Statement (EIS) Contents: The draft EIS evaluates the potential environmental impacts of siting, constructing and operating a new recycling and transfer station associated with each alternative. It covers aspects of the built and natural environment including, but not limited to, the following areas: earth, air, water, plants, animals, energy, natural resources, environmental health, land use, transportation, public services, and utilities. Three alternatives are evaluated in the document, including two action alternatives and a No Action alternative. The alternatives are:

- No Action Alternative - 35315 West Valley Highway South, Algona (existing Algona Transfer Station)
- Alternative 1 - 901 C Street SW, Auburn
- Alternative 2 - 35101 West Valley Highway South, Algona (Preferred Alternative)

Public Comment Period: Agencies, Tribes, and members of the public are invited to review and comment on the draft EIS. The Division will consider all comments received during the comment period, as well as comments received during earlier EIS scoping periods, for consideration in the Final EIS.
