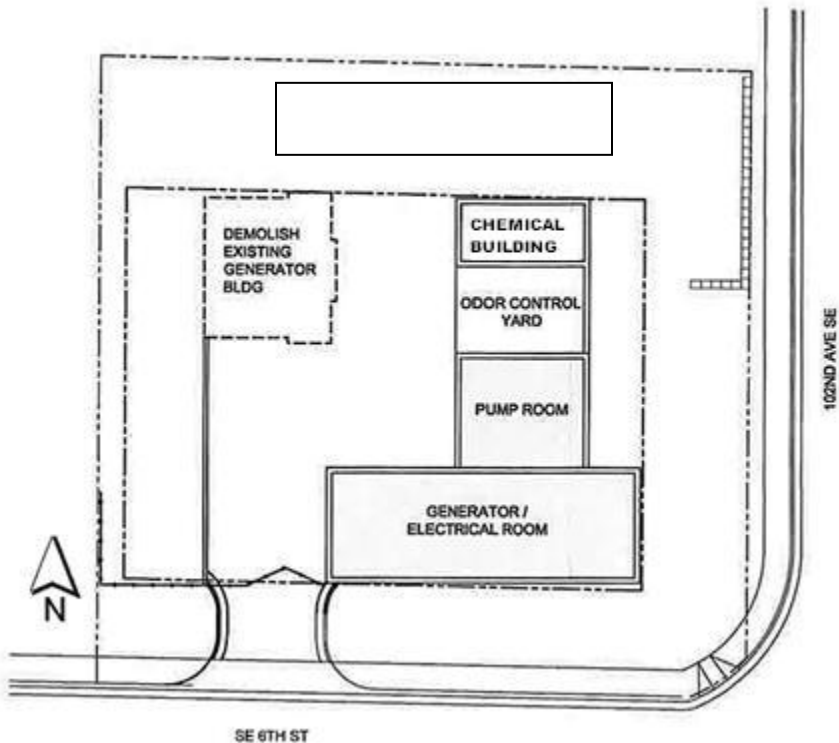

Bellevue wastewater pump station improvement project begins in mid-September

Southeast 6th Street closed between Southeast 6th Street Park and 102nd Avenue Southeast

To protect public health and the environment, King County will make improvements to its wastewater pump station at the corner of Southeast 6th Street and 102nd Avenue Southeast in Bellevue. The existing pump station is more than 40 years old and must be expanded to accommodate Bellevue's growing wastewater treatment needs.

Over the next two years, the above grade pump station will be demolished and replaced with a facility featuring more powerful pumps, a new generator building, stronger odor control equipment and updated architecture.



Upon completion, the refurbished pump station will be able to convey more than 13 million gallons of wastewater daily from west and central Bellevue to the county wastewater treatment plant in Renton -- a 60 percent increase in capacity.

King County is committed to being a good neighbor. Sound walls will muffle noise coming from the site and fencing erected around the work site will protect public safety. The project team will keep the community regularly apprised of the work schedule via e-mail and written notifications, and will be available to answer questions 24-hours a day via the project hotline: 206-296-4081.

What to Expect

- The most disruptive work will occur in the first year when crews demolish existing structures on site and build a temporary pump station bypass.
- Increased noise, dust and activity typical of a construction site. Heavy equipment will be in use at the construction site on most days.
- Increased truck traffic on Southeast 6th Street and 102nd Avenue Southeast.
- Most work will occur weekdays between 7 a.m. - 5 p.m. Some work may be required at night when wastewater flows are lower.

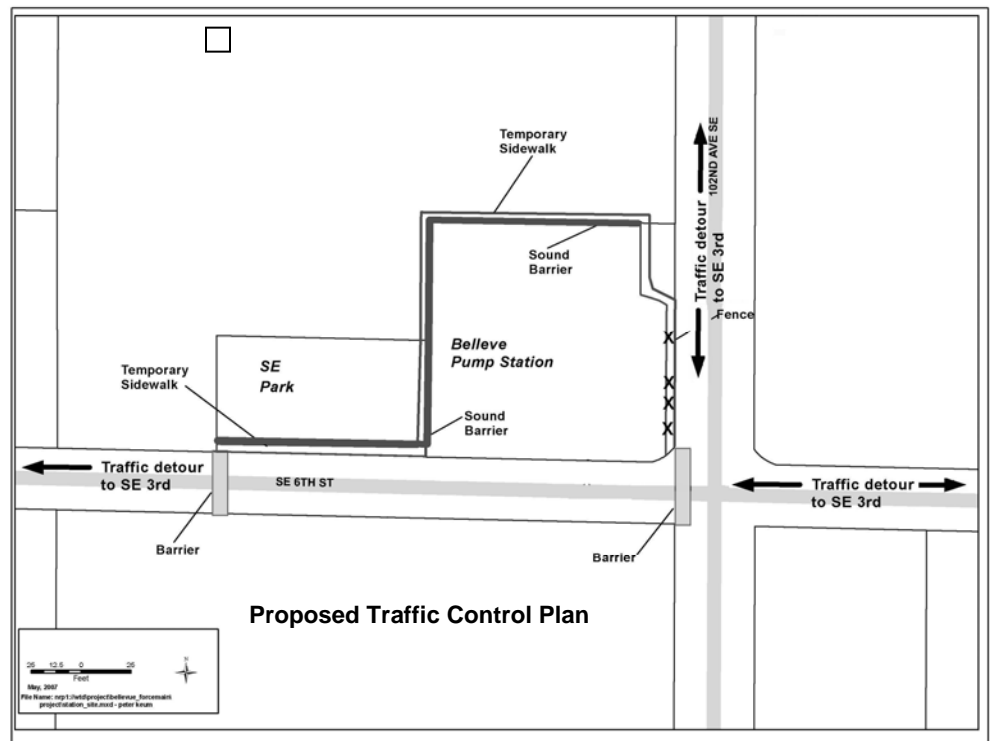

BELLEVUE PUMP STATION UPGRADE FALL 2008

- Southeast 6th Street will be closed between Southeast 6th Street Park and 102nd Avenue Southeast for the duration of the project. Traffic seeking to pass between 100th and 102nd Avenues Southeast will detour around the work site on Southeast 3rd Street and 101st Avenue Southeast.
- Southeast 6th Street Park will remain open to the public from 102nd Avenue Southeast via a temporary sidewalk extending around the northern and western border of the work site. The sidewalk in front of the pump station on Southeast 6th Street will be closed throughout the project.
- The work site and staging area on Southeast 6th Street in front of the pump station will be fully restored at the end of the project



Work sequence

- Temporary bypass installed and tested
- Demolish pump station
- Rebuild pump station
- Demolish and rebuild new generator building, odor control area and chemical room
- Test facility
- Restore site
