# Traffic Impacts - 102nd Avenue SE

**Bellevue Influent Trunk Project** 

### **Current Work**

This week, crews started pipeline boring under the Meydenbauer Creek box culvert. The pipeline will be constructed under the culvert with above-ground access pits on both sides to allow room for the construction equipment. To do this work, groundwater continues to be pumped out of the immediate work area (24 hours a day) into a dewatering settlement tank.

# One-way northbound 102<sup>nd</sup> Ave. SE

The start of pipeline construction corresponded with the beginning of the project traffic revision on 102<sup>nd</sup> Ave. SE. This revision includes **one-way northbound traffic on the west side of 102<sup>nd</sup> Ave. SE.** Traffic is not permitted southbound on 102<sup>nd</sup> Ave. SE from SE 3<sup>rd</sup> Street.

#### **Intermittent Closures**

Large construction equipment is needed to complete the pipeline boring work. At times, maneuvering this equipment will require short-term intermittent street closures on 102<sup>nd</sup> Ave. SE (at the mid-point of SE 6<sup>th</sup> St. and SE 3<sup>rd</sup> St.). **Expect periodic, short-term intermittent street closures on 102<sup>nd</sup> Ave. SE for the next couple of weeks.** 

#### **Future Driveway Impacts**

In several weeks, crews will start pipeline installation in the roadway north of the culvert. This construction will require work for extended periods in front of driveways. As provided for in the contract, **those with pipeline** work occurring directly in front of their driveways (limiting access) will be provided 48 hours notice in advance of work. The notice includes the dates of planned work, in addition to the times when access will be provided: at all times from 5:30 pm to 8:00 am; for 15 minute increments at 10:00 am and 3:00 pm; and for a 30 minute increment at 12:00 pm.

#### What you can expect:

- Work hours will occur between 7 a.m. and 6 p.m. Monday to Friday, and 9 a.m. to 6 p.m. on Saturday if/when necessary.
- Additional noise and activity: work crews, heavy machinery, dust, trucks, and construction materials.
- Traffic control and flaggers onsite daily to manage traffic flow and local access.
- Emergency vehicle access maintained at all times and coordination with other public services.
