Update: Important project updates on our Online Open House

King County's Magnolia team has important construction updates to share with our project neighbors and the Magnolia community. The City is issuing the permit for staging for pipeline assembly and installation in a location that will maintain access for almost all residents on 32nd Avenue West throughout the project, and reduce the time required to install the pipe.

The current staging plan requires closure of 32nd Avenue West between Clise Place West and 33rd Avenue West. This closure is expected to begin on Thursday, March 1 and last up to five weeks. The contractor will deliver and assemble pipe sections in this area. To reduce impacts to residents on 32 Avenue West, the pipe sections will be stored at the Port of Seattle before assembly.

During the pipe bursting and pull process, which is expected to last approximately three days in mid-April, only a few residents will have access limitations. The project team will work closely with these residents to meet their needs during this time.

In December 2017, we launched an interactive online open house to share construction and schedule information with the community. With crews beginning to fuse the pipe in early March, we encourage you to view our updated online open **house.** You'll learn more about:

- Construction method
- Construction activities and schedule
- Short-term road closure on 32nd Avenue West
- Temporary parking removal on Clise Place West

After you have reviewed the open house, you can submit additional thoughts and questions to the project team on the final station labeled "For more info."


Please continue to share this information with your neighbors, and encourage them to visit. The online open house will remain open for you to visit through the spring and will continue to be updated, if needed.
