Crews to begin trenchless pipe installation next week on Southeast 264th Street

King County contractors are continuing construction on the Kent East Hill Diversion pipeline. The new sewer pipe will provide sufficient capacity to meet Kent's needs through 2050 and reduce the chance of sewer backups into homes and streets.

UPCOMING AND CONTINUING WORK

- Trenchless pipe installation begins. Next
 week, crews will begin installing the new
 pipe underneath Southeast 264th Street
 without excavating a trench on the surface
 of the street. This trenchless pipe
 installation will begin at the bore pit and
 head west, ending on school property at
 the tunnel receiving pit (see map).
- Work continues on school property. Crews completed excavating the tunnel receiving pit on Kent Phoenix Academy property and are beginning to install the new pipe along the east side of the school.

COMPLETED WORK

 Launch bore pit complete. Crews completed the launch bore pit on the west portion of Southeast 264th Street (see map).



Expect lane restrictions and limitations to parking in work areas along Southeast 264 Street. *Please use caution in work areas and follow posted traffic signs and flaggers.*

WHAT TO EXPECT DURING CONSTRUCTION:

- Work will occur from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas during construction
- Parking and pedestrian restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Extra travel time when driving through the work area
- Noise and other activity typical of a construction site: work crews, dust, trucks, heavy machinery and excavating equipment


