# Pipe installation nearly complete; Restoration activities begin January 2014

King County contractors are continuing construction of the Kent East Hill Diversion pipeline and will begin restoration work after the end of the year. The new pipeline will help provide sufficient capacity to meet Kent's needs through 2050 and reduce the chance of sewer backups into homes and streets.

## **PROJECT UPDATE:**

# Open-trench pipe installation nearly complete.

Crews are almost done installing the new sewer pipe along S.E. 264th St. between the bore pit location and 114th Ave. S.E. (see map). This work is expected to be completed by the end of 2013.

**Restoration activities begin January 2014.** Once pipe installation is complete, crews will start restoration work on the south side of S.E. 264th St. west of 114th Ave. S.E. by restoring curbs and gutters and then grinding, grading and paving the road to restore it to City of Kent standards.


At the same time, crews will start planting activities on both school property and the pond at 114th Ave. S.E. and S.E. 264th Pl. to restore the landscaping to school and City of Kent standards.

Restoration work is expected to be completed February 2014. *Restoration work is weather dependent*.

**Settlement monitoring inspections** will continue on S.E. 264th Pl. through the end of construction.

#### WHAT TO EXPECT DURING CONSTRUCTION:

- Normal work hours from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas
- Parking and sidewalk restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Increased travel time when driving through the work area
- Noise and other activity associated with a construction site: work crews, dust, trucks, heavy machinery and excavating equipment



Expect lane restrictions and parking limitations in work zones. Please use caution and obey flaggers and posted traffic signs.
