Sunset and Heathfield Pump Stations and Force Main Upgrade

Construction Update: September 20th

Here are the planned closures and updates on work related to the Sunset and Heathfield Pump Stations. *The schedule and duration for the work and closures is subject to change.*

164th PI SE

- This week, crews continued to drill underground between the large pits on 164th PI SE near Vasa Creek.
- Saturday work will continue at this location until this section of pipe is installed by late-October.

West Lake Sammamish Parkway

- A single lane of W Lake Sammamish Pkwy will be closed on Friday, September 21 from 9 a.m. to 3 p.m. Crews need to close the lane to investigate a bulge in the pavement near the intersection of SE 38th St.
- The intermittent weekday single-lane closures on W Lake Sammamish Pkwy near Sunset Pump Station will continue as necessary to allow crews to move equipment in and out of the pump station.
- Both lanes of traffic will be open to traffic outside of work hours.

163rd Ave SE

- The intermittent weekday single-lane closures on 163rd Ave SE will continue during work hours. This will accommodate jack-and-bore and Heathfield Pump Station construction activities.
- Crews will need to close a single-lane of 163rd Ave SE as they install dewatering equipment. The earliest this closure will occur is on Wednesday and Thursday, September 26 and 27 from 7 a.m. to 7 p.m. If the work does not occur next week, we will include updated schedule information in our next construction update.
- Both lanes of traffic will be open to traffic outside of work hours.



What to expect:

Work hours:

- Mondays through Fridays, 6:30 a.m. to 7 p.m.
- Saturdays on 164th PI SE near Vasa Creek, 6:30 a.m. to 7 p.m.

Note: Equipment will not start until 7 a.m., per the City of Bellevue Noise Ordinance

Closures (see map)

- 164th PI SE: two full 24-hour road closures near SE 35th St and 163rd Ave SE
- SE 35th PI: Single-lane closures
- 163rd Ave SE: Intermittent single-lane closures
- W Lake Sammamish Pkwy: Intermittent single-lane closures

Note: Flaggers and signage will assist drivers in detouring around closures. Access to homes and driveways will be maintained and prioritized for the duration of the closures.

Increased noise and vibrations: Neighbors can expect noise and vibrations from excavation for pit creation, shoring, boring machines, vacuum trucks, pipe installation, and generators.

Parking impacts: Select street parking will be removed during this phase of work. Please adhere to the no parking signs posted by the contractor.

Access maintained for services: Access will be maintained for emergency services, waste pickup, and mail delivery.
