## Deferred Compensation Plan LEAVE CONTRIBUTION FORM



If you are retiring from King County or separating for other reasons, you may be eligible to contribute the value of your unused vacation, comp time, and up to 35% of your sick leave balance to your Deferred Compensation Plan account. By making a pre-tax deferral, you can reduce taxes withheld from your final paycheck and boost your retirement savings.

Keep in mind, the IRS limits the amount you can contribute to retirement plans each calendar year. For details contribution limits, go to kingcounty.gov/employees/benefits/deferred-comp.aspx.

**Important:** Some collective bargaining agreements require that leave balances go into an HRA VEBA account.
