#### Welcome and Call to Order

Co-Chair Miller called the meeting to order at 6:02 p.m.

#### **Discussion of Public Comment Letters received by Commission**

Discussion was held regarding public comment submissions and whether the Commission wants to take up any further topics based on those comments. In response to a question about translation of materials, it was noted that the town hall materials will be translated into nine languages. Public comment letters will be included as an appendix to the Commission's report. A letter from the Sound Cities Association was read to the Commission and will also be included.

# Commissioner Nixon moved that the letters be included in the report to provide content for the future Charter Review Commission to take up. The motion was adopted.

Letters that arrived late in the process will be included with whatever is received at the town halls for consideration at the next meeting. A copy of any public comment submitted will also be available at the town hall meetings.

# Review Commission decisions to-date and discuss remaining proposals for charter amendments

A document outlining the decisions the Commission has already made was provided in the meeting materials. The anti-discrimination language recommended by the Equity Subcommittee was also provided.

Action: Staff will ask the Prosecuting Attorney's Office (PAO) for an opinion on whether anti-discrimination language related to discharge solely based on sexual orientation or gender identity would put any federal funding at risk. Also, the PAO will weigh in regarding immigration status and criminal history as protected classes.

Discussion regarding how comments submitted might be incorporated into the discussion. Written submissions from the public along with comments from the public forums will be addressed at the October 23, 2019, Commission meeting.

- Motion: Moved by Commissioner Ceis and seconded to accept the proposed antidiscrimination language. The motion passed unanimously.
- Action: Staff will include the anti-discrimination proposal as written. Handout will be updated and font corrected.

## Review and approve amendment language and/or justification for each charter amendment

Variations in the document language were discussed.

Action: The Draft Charter Amendments document will be updated to include the actual language that will be submitted for each item. Staff will send out an email with the updated document.

If there are any corrections or comments, Commissioners should send comments to staff.

Discussion was held regarding whether to include ranked-choice voting in the public handout. It was determined that it would not be included in the town hall handout, but would be included as a topic in the report to the Council. The subcommittee will need to provide some language regarding how that would be drafted.

#### Review outreach strategy and materials for October Town Hall meetings

The Executive and County Councilmembers sent the outreach information out to their constituents via social media. Commissioners were also encouraged to share the information. Discussion ensued regarding the inclusion of ethnic media, contacting the Seattle Times regarding doing an editorial, utilizing radio and sending out press releases.

Action:

- Staff will send out list of where they plan to advertise, along with the content that is going out through Council and Executive social media.
- Staff will draft and send out a press release.
- Staff will ensure that local elected officials are aware of the town hall meetings.
- Calli will send out social media toolkit with image descriptions.
- Sung will reach out to Northwest Asian Weekly and the Seattle Times.
- Nikkita will reach out to Crosscut, KUOW and KVRU.
- Tim willing to be a contact on the press release.
- Toby will reach out to the contact for the Reporter newspapers.

Media wishing to speak to a commissioner will be directed to staff who will determine Co-Chair Miller's availability to speak with them.

#### Scheduling and next steps

The commission discussed the format for the town halls and the materials that will be available. It was requested that it be made clear that public comments can be submitted online in lieu of speaking at the town halls.

- Ranked-Choice Voting the report drafted by Commissioners Nixon and Heller will be put in the form of the rest of the report and included as a recommendation to the Council to create a task force to look at this more in depth and then consider it further.
- Revisit Appointment of sheriff based on public comments received include layer of protection that prevents removal at whim. See if the language used for the Director of Public Defense can be adapted for an appointed sheriff. This item will be addressed further on November 6<sup>th</sup>
- Preamble language "Racial equity". This item will be addressed further on November 6<sup>th</sup>
- Replace "citizen" with "resident" throughout the Charter. This item will be addressed further on November 6<sup>th</sup>
- Replace the "Office of Citizen Complaints" with a "Community Advocate". This item will not be addressed further. Will be recommended to Council for further consideration.
- Section 840, Antidiscrimination language. This item will not be addressed further.
- Director of Public Defense language to protect independence. This item will not be addressed further.
- Antidiscrimination, add protective hairstyles (authenticity statute). Will be recommended to Council for further consideration.
- Charter Review Commission Process. These items will be addressed further on November 6<sup>th</sup>:
  - o Onboarding.
  - Engagement process using deliberative democracy to select members of the Charter Review Commission.
  - Refer amendments straight to ballot rather than to the County Council.

Prior to the next meeting a full draft report will be provided, to be discussed at the first meeting in November. The nine confirmed items are all in ordinance form, however the summary of the justification for each needs to be addressed by the Commission. The Preamble item will not be included in this version of the report. Included in the report will be items the Commission encourages the Council to further consider.

All of the comments received, including a summary of the comments, will be included in the report to the Council.

The November 6<sup>th</sup> meeting will be for discussion of the items talked about tonight, and the November 20<sup>th</sup> meeting will be to finalize the report.

#### Section 260 Office of ((Citizen)) Public Complaints.

23 The county council shall establish by ordinance an office to receive complaints 24 concerning the operation of county government and shall grant it sufficient power to permit 25 it quickly and efficiently to investigate and to make and publicize recommendations 26 concerning its findings, including the power to subpoena witnesses, documents and other 27 evidence and to administer oaths. The subpoena power of the office of ((citizen)) public 28 complaints shall be limited to matters under written complaint by a ((citizen of the county)) 29 member of the public, and any witness shall have the right to be represented by counsel. Any 30 individual who is the subject of a complaint shall have the right to present witnesses in the 31 individual's own behalf.

#### Section 800 Charter Review and Amendments.

33 At least every ten years after the adoption of this charter, the county executive shall 34 appoint a ((citizen)) resident commission of not less than fifteen members whose mandate 35 shall be to review the charter and present, or cause to be presented, to the county council a 36 written report recommending those amendments, if any, which should be made to the 37 charter. Appointees shall be subject to confirmation by a majority of the county 38 council. This ((eitizen)) resident commission shall be composed of at least one 39 representative from each of the county council districts. The county council shall consider 40 the commission's report and recommendations and decide at an open public meeting how to 41 proceed on each of the commission's recommended charter amendments, as provided by 42 ordinance.

The county council may propose amendments to this charter by enacting an ordinanceto submit a proposed amendment to the voters of the county at the next general election

- 2 -Page 20 45 occurring more than forty-five days after the enactment of the ordinance. An ordinance 46 proposing an amendment to the charter shall not be subject to the veto power of the county 47 executive. Publication of a proposed amendment and notice of its submission to the voters 48 of the county shall be made in accordance with the state constitution and general law. If the 49 proposed amendment is approved by a majority of the voters voting on the issue, it shall 50 become effective ten days after the results of the election are certified unless a later date is 51 specified in the amendment.
