# 3. WTD Director's Report- Pam Elardo, P.E., Director, Wastewater Treatment Division (WTD)

### 2014 Northwest Flower and Garden Show

WTD Staffed the LOOP booth at the show that ran from Feb. 5-9 and gave away thousands of LOOP samples. This is typically the best public event for biosolids information during the year. Ticket sales were down this year, but still a lot of interest in the product.

### Human Health Water Quality Standards

US EPA is proposing changes to the human health criteria and methodology under the Clean Water Act that is used to regulate the discharge of chemicals into an aquatic environment. The proposed changes are expected to be released at the end of February or March and there will be a 60-day comment period. King County staff will be reviewing as this could impact WTD's discharge limits and other aspects of our operations.

## South Plant Digesters

Extensive upgrades and renovations were just completed on Digester 1 at South Plant. Upgrades and repairs were made to the floating digester cover, sludge piping, digester gas piping and pressure relief system. All four digesters will ultimately be upgraded. These digesters were originally constructed in the 1980's.

## East Waterway Superfund Cleanup

The East Waterway Group (EWG) recently submitted the first draft of a feasibility study to US EPA. Initial cost estimates range from \$235 to \$380 million. These cost estimates have similar range to that of the Lower Duwamish even though the East Waterway cleanup area is one-third the size. This is because most of the East Waterway site will require dredging. EPA will submit comments to EWG and then a final draft of the feasibility study will be released later in 2014 for public comment. This timeline will likely change.

## State Revolving Loan Fund (SRF)

Good news last week from the State, WTD received the maximum loan amount for four of our capital projects. Those projects are the Fremont Siphon Upgrade, South Magnolia CSO Porject, Barton CSO Control Project and the North Beach CSO Project. The total award for all 4 projects was \$67,500,000. SRF loans offer very favorable interest rates, resulting in lower borrowing costs for ratepayers. Our Murray CSO Project also ranked high, but we had already received the maximum loan amount in this loan cycle. We will reapply for funding for Murray next year.
