



Jim, Thank you for bringing this to our attention. For work within the public right of way, we have been requiring our utility applicants to notice the property owners 1 week in advance of the beginning of their work. If the work they are setting up for is along East lake Sammamish Parkway, then that requirement should have been stated on their permit letter. However, if the work is along Shore Lane, they did not require a permit from this office. The May letter may have been the only requirement by King County as this is within their project limits. I will have my inspector verify what work is being done. In reference to the Schedule, the work along Zackuse Creek was separated between the City and King County. Originally we hoped to combine them into one project but funding issues resulted in keeping them separate. It is my understanding the King County is opening bids for the two culverts this month with work to begin shortly soon after. I will have Tawni check into their schedule when she is back in the office and then have her contact you directly. The City project still includes replacing the culvert under East lake Sammamish Parkway and restoration of stream habitat to the east. Our contractor is currently mobilizing and will be stating on July 8th. Work along the parkway is currently scheduled to occur from mid-July through the end of August. There is a two week road closure occurring in the middle of August. If you have any other questions, please do not hesitate to contact me directly. Hi Evelyn,

Thanks for your email. Would it be helpful if I came by with the plans to show you what the construction will look like? I'd be happy to do so. There will some construction staging on County property north and south of where you're currently parking, but you'll still have parking for your two vehicles. There is no plan to relocate any utilities onto your property. I did call our contact at Puget Sound Energy to ask about how you can have natural gas brought to your home. When you're ready to get the process started, call (888) 321-7779 to request new residential service. The project manager for your area, Virginia Fulton, has researched your property and it looks like the gas main runs along Shore Lane which will keep your costs much lower than had it been under the East Lake Sammamish Trail. I'd like to talk about your concerns with the mailboxes. If they're something we can't find a fix for we'll go back to the Post Master and request an alternative site.

To clarify, the culverts on Shore Lane, East Lake Sammamish Parkway, and Trail are being replaced in response to the dwindling population of Lake Sammamish Kokanee salmon. The existing culverts are barriers to this threatened species and the replacement culverts are specifically designed for salmon migration. The three new culverts will work in concert to improve access to over mile of upstream spawning waters for the Kokanee. The parkway project will begin in June and trail culvert projects in July. Residents of Shore Lane are being asked to sign a temporary construction easement (TCE) because Shore Lane is a private drive. The Shore Lane culvert replacement will also improve drainage between Shore Lane and the trail and replace the existing sever and water lines that cross under Shore Lane. I have attached a copy of the plan drawing for the Pine Lake Creek culvert replacement on the East Lake Sammamish Trail and adjacent Shore Lane, with your property highlighted in green. The purpose of the project is to replace existing culverts with ones salmon can pass through in order to improve the health of native Kokanee salmon populations. Replacing the existing culverts will better connect habitat in Lake Sammamish to spawning areas upstream. Our next step is to take soil samples adjacent to the existing culvert to aid in the culvert design. We are hoping to perform this work in the next month. The culverts will be replaced as part of East Lake Sammamish Trail (ELTS) segment B work, which should begin in 2019. I (Pete) provided early July to late October as the tentative dates, and forwarded Craig Buitrago's description of the detour's capacity to the Wolfs. I also pointed out the limited turnaround area on Shore Land. Craig's description is: "The temporary access route via the East Lake Sammamish trail will accommodate ASHTO HL-93 vehicle live loading. This is the same loading as for highway bridges, so the access route and box culverts will be able to support emergency vehicles, concrete trucks, excavators, moving trucks, etc. The turning radii of the construction entrances and temporary access routes were also designed to accommodate emergency vehicles, concrete trucks, excavators, etc. Therefore, the access route will handle the turning radius of moving trucks. Please note that both Shore Lane NE (10 feet wide) and the East Lake Sammamish trail access routes (20 feet wide) may not be wide enough for two-way excavator or haul truck traffic. Traffic control measures such as signage and guide posts will be installed to guide the temporary access route users all time of the day.
